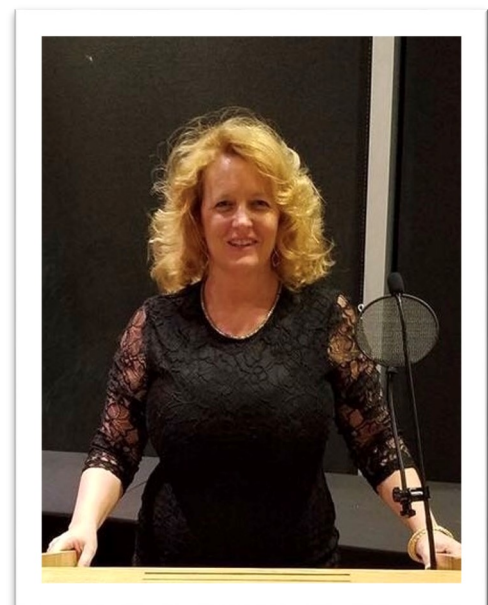

LEGISLATIVE UPDATE

Despite all the infighting, there are gains being made in Washington D.C. Some of this year's accomplishments are:

The Water Infrastructure Financing and Innovation Act (WIFIA) will provide \$2.3 billion in financing this year. This is new funding. NUCA began advocating for WIFIA in 2013. EPA's State Revolving Funds (SRF) will be funded at levels similar to last year: Clean Water SRF = \$1.143 billion; Drinking Water SRF = \$863 million.

Waters of the United States (WOTUS) rule was repealed. This will save billions of dollars in compliance costs. This was a lobbying priority during the Washington Summit.

The House of Representatives unanimously passed the Strengthening Career and Technical Education for the 21st Century Act (H.R. 2353). This will make it easier for career & vocational/technical schools to offer trades-oriented curricula. We lobbied for this act during the Washington Summit and NUCA is now working closely with Senators to draft the Senate companion bill.

NUCA continues to monitor proposed legislation and advocates for any & all legislation that helps our industry to thrive. Advocacy in D.C. is important, but just as important is local support. The more calls, emails, letters, etc. that we make to our congressmen, senators & their staff, the more likely we are to achieve success. Please reach out to any SUCA board member if you care to get involved. We'll ensure you have all the information you need to help us improve our industry.

There are lots of moving pieces in Congress surrounding NUCA's priorities.

Healthcare

The Senate Republican leadership's plans to move the Better Care Reconciliation Act, or 'repeal and replace' of the Affordable Care Act, have been foiled as 4 GOP Senators (Collins, Lee, Moran, Paul) said they would not support the latest plan. [Forbes has an informative article about the latest version.](#)

Senate Majority Leader McConnell said yesterday that the Senate will shift away from the idea of 'repeal and immediately replace' and pursue simple repeal by . In order to do so GOP leaders will have to convince GOP Senators to vote yes on what is called a 'Motion to Proceed' on the House passed Obamacare repeal/replace plan, which essentially allows the Senate to move legislation to the floor for action. If this passes, then the Senate would begin 20 hours of debate, then vote on amendments (unlimited), which would include an amendment that would actually substitute the entire bill out for a 2015 passed (but President Obama vetoed) repeal bill. IF the repeal passes the Senate, most expect the House to pass it as-is and send it to President Trump's desk for signing. This plan is contingent on a few significant assumptions: 1) that Senate Leadership can get the votes to proceed to the Senate floor for action, 2) that the debate and amendment process doesn't sink the bill by adding amendments that cause GOP deflections 3) that GOP Senators can vote for a repeal of Obamacare without a replacement plan. Tax Reform

Yesterday, House Budget Committee Chairwoman Diane Black (R-TN) unveiled the FY 2018 budget blueprint. The important part here is that the plan reduces the deficit by \$6.5 trillion over 10 years, which gives the Ways and Means Committee (the committee responsible for writing tax laws) \$6.5 trillion over ten years to play with in terms of developing a tax reform package. The budget achieves this by making steep budget cuts to everything but defense. Read more about the proposed [budget here.](#)

Last week NUCA was asked to submit comments to Senate Finance Committee Chairman Orrin Hatch (R-UT) outlining our priorities for Tax Reform. Specifically we ask that individual and corporate rates be lowered simultaneously, that specific tax-exempt bond mechanisms be retained and expanded for infrastructure investment, and that businesses' retain the ability to delay tax on capital improvements. Appropriations

Yesterday, House Appropriators passed the Interior/Environment Appropriations bill that funds EPA's State Revolving Fund loan program. The legislation keeps SRF funding level, avoiding deep cuts from the top-line of EPA's budget, and funds the WIFIA program at a higher-than-expected level of \$25 million

All of these measures moving simultaneously emphasize the need for broad participation in NUCA's August Recess Challenge. Schedule meetings with your lawmakers while they are home from Washington and advocate for our priorities. The individual or chapter that meets with the most Members of Congress during the August Recess will win a free registration to the 2018 Washington Summit. The timing couldn't be more appropriate for our priorities.

Polk State College

We are excited to announce the first ever Infrastructure Construction Program to be released in Fall 2017 at Polk State College and Hillsborough Community College. This program was created by the SUCA Education Committee to include Chairman Bill Bocchino, Vogel Bros. Building Co. putting the research and time in with Polk State College to make sure all needs of the Infrastructure Industries are met.

The program will be 13 months long and the estimated cost will be roughly \$10,000 per student. SUCA is currently pursuing grants with career source to reduce program cost. Each student in the program will have 3 days in the field working for a contractor and 2 days at school learning in the classroom. The program will consist of 7 stages to include Construction Craft Laborer, Pipe Fitter, Pipe Layer level 1 & 2 (Industry specific topics), Construction Craft Laborer, Heavy Highway

Construction level 1 & 2.

We are confident this program will equip the students with all aspects they will need to be successful in our industry. They will graduate with a plethora of certifications that all contractors need their employees to have for safety and success in the work place.

We hope contractors take advantage of this innovative program and help bring the younger generation back into our industry.

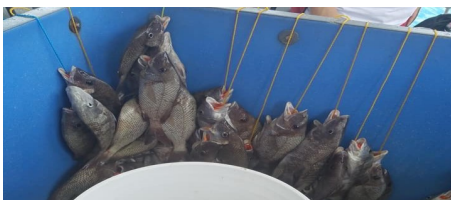
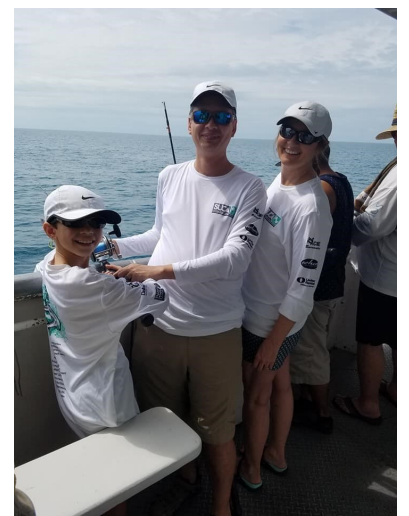
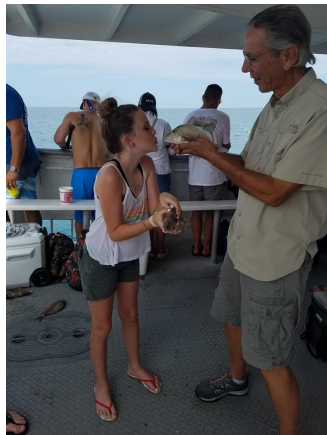

LOCAL, FEDERAL LAW REQUIRES CALL TO 911 WHEN PIPELINE DAMAGED

Sunshine 811 provides tools to reduce likelihood of damages and max federal fines up to \$2 million

DEBARY, FL, (June 21, 2017) – Effective July 1, 2017, Florida excavators will be required to call 911 to report any contact with an underground facility that results in the release of a natural gas or other hazardous material or substance regulated by the Pipeline and Hazardous Materials Safety Administration (PHMSA) of the United States Department of Transportation.

The 911 provision was one of five specific amendments to the Underground Facility Damage Prevention and Safety Act, Chapter 556, Florida Statutes, signed into law by Gov. Scott June 14, 2017.

“You’re still required to stop excavation or demolition activities that may further damage the underground facility until the repair is complete,” explains Sunshine 811 Executive Director Mark Sweet. “It also does not change the existing requirement to notify member utilities immediately when you contact or damage a pipe, cable or its protective covering.”

Protect yourself

Avoid damaging underground facilities by always notifying 811 before you dig to request locate marks and then following the special procedures for High Priority Subsurface Installations (HPSI).

These are underground transmission or distribution pipelines used to transport any gas, refined petroleum product or hazardous/highly volatile liquid such as anhydrous ammonia or carbon dioxide that are deemed critical and identified as HPSI by the facility operator.

Check the Sunshine 811 Positive Response System early and when you’re at the job site. Access it at sunshine811.com.

When you see positive response code 2C: “Marked with Exceptions – High Priority subsurface installations in conflict” this is what you need to know:

1. The pipeline operator has determined that your proposed dig site is within 15 feet of their HPSI pipeline. They know what they’re talking about!
2. ***You MUST contact the pipeline operator/member utility with the start date and time for the excavation or demolition so that they may be present during the excavation. This is important and required by Florida law.***

Protect your business

Damaging pipelines carries its own set of risks. But now, PHMSA may place maximum civil penalties of \$209,002 per violation per day with a maximum of \$2,090,022 for any related series of violations on any Florida excavators who damage their regulated pipelines.

PHMSA has developed a Federal Standard for Excavators (49 CFR Part 196) consisting of six elements that mirror what we teach online and during in-person sessions:

Persistence counts even when you don’t get the 2C code

All jobs should be visually inspected before digging. That means compare the codes on your positive response summary to what you see in the field. Look for pipeline and other buried permanent utility markers. These could be a sign that there may be more at your jobsite than you think. If something doesn’t look right, contact 811 or the utility. Remember, your safety and \$2 million are on the line!

Defending Utility Damage Claims “When the Excavator is Not-At-Fault”

If ever there is a utility damage, it is critical to make as many preemptive strikes to prevent the claim from ever being issued. Here are some things to consider.

1. What the excavator does immediately after a damage is extremely critical and the following actions should be considered:

- Call the locator out to the site and take their statement -- good, bad or otherwise, get the statement. Very often, the locator will admit guilt or admit to making bad locate, but

- Ask the utility to verify locate accuracy by hand digging enough points to be certain the excavator can rely on accuracy, especially in fiber optic cases which have vulnerability to damage while potholing.

- Ask them about the techniques and equipment they will be using to locate the area.

- Ask them of their concerns about the accuracy of their locating. There is a long list of locating problems that all locators have.

- Ask them for the "quality of data" they are using for locating. Most locating today is done with quality level "D" As-Built data, with quality level "A" data being data recovered by a surveyor who dug it up and confirmed its location with survey accuracy.


- Ask to be present when they are locating.

- Show the locators the position of utilities represented on the construction drawings so they can compare them to their as-built information.

- Document the position of locate markings using photography and ask the locators to document as well.

- Ask locators to be present when you are digging. Utilities and their locators may refuse to do some of these things, but it is important to document your requests and ask for written answers for why they can't or won't.

It absolutely makes no sense to be forced to pay a damage claim when, as an excavator, you are not at fault. By collecting the documentation to win a damage claim on the "day of the damage" you are much more likely to have the information necessary to defend a claim when it is billed six months later. The rule always applies: "He who has the thickest file usually wins." This rule was learned by spending a lot of years defending utility damage claims.

Now, here is a bit of good news! As an excavator, if you put these systems in place to "defend damage claims," your vulnerability for being responsible for damage decreases dramatically. And, when you do have damage for which you are not at fault, the likelihood for being billed decreases as well. In the final analysis, the best way to defend a damage claim is to "not have damage."

that typically does not get captured. Get signatures and if they refuse, note the refusal.

- After meeting with the locator, call the utility and get statements made by them with the locator present about the damage not being the fault of the excavator. Ask for an affidavit stating that the excavator is not at fault if that is indeed the case. Or, at least make a note in the Daily Diary and ask the locator to sign it. If they won't provide verification that you are not at fault begin calling "up the chain of command" at the utility and locating organization.

- It is terribly critical to document every aspect of the damage immediately after the damage and before repairs are made. It is rare, but we have seen locators come back out and paint marks on the ground to make it look like the locate was correct. Document the proximity of the locate marks to the damage with "precision." The best practice of all is to have a surveyor document the marks and the location of the damage; photographic documentation is rarely good enough unless you use "Rhino Kits" to show distances with photography.

- It is critical to record every aspect of the repair process in great detail. Ask for names of repair people, tag numbers of vehicles, times repair people arrive at the site and time leaving, the amount of time they take breaks, what material they use (photograph), and what equipment they use. The more information, the better.

2. The excavator must always understand that it is the practice of a very limited number of utilities to bill for damage, whether or not they believe they were at fault or if there was a bad locate. They may send a bill six months after the damage when the excavator rarely can "prove" they were not at fault. So, they generally collect at least 50% of their claim because insurance companies will pay when they do not have enough excavator documentation that proves their excavator was not at fault:

- It can be so bad that it is important for excavators working in any given area to take note of any damage that occurred with anyone else working in the same area, even if it is across the street. We have seen excavators billed for the damages of others numerous times.

- We must defend against this tactic by taking the measures suggested above or at least calling the utility whose facility you know was damaged and note who did the damage to protect your company.

- You can report damage with the One Call System as well, so the word gets back to the utility. And, sometimes, the error on the part of the utility is just that... an error.

3. Billing the utility for excavator downtime can be a powerful preemptive strike:

- The excavator is unlikely to collect because of the amount of aggravation and cost, but it is worth sending a bill. If nothing else, it will flush out their "wrongful" damage claim. Then you will have all the necessary documentation to defend against their claim should it be issued.

- If the excavator is working for a public owner, it is usually helpful to involve them in doing their own verification that you were not at fault. If there is a contractual obligation of the utility to the public owner, there may be an opportunity for cost recovery through the contract.

4. Air grievances against a utility in the public forum:

- All utilities participate in utility coordinating groups that excavators can attend and you can air your issues there.

- Notify the One Call system of the grievance to be aired.

5. Ask the locator to document compliance with all of the "Locator Best Practices" that are found in documentation by the Common Ground Alliance:

- You can take a print-out of the Locator Best Practices, go over them with the locator and simply ask "Do you do this?" Just record yes or no. If they give you honest answers, you win. If they do not answer, you still win. I promise you they have many failures in their own practices that impact locating.

- Conduct a "Root Cause Analysis" for locators based on their compliance/or lack of compliance with best practices. While unlikely, they will provide the answers that can be recovered if you need them later

6. Document all of your "Excavator Best Practices" that were used to prevent damage in any particular case and in general:

- The hardest approach for a utility to break is "Excavator Best Practices" when they are done. Ask yourself the "Do we do this?" questions with regard to the Excavator Best Practices. Every time you have a "yes we do this" answer, you are much more difficult to beat in a wrongful damage claim and much less likely to have a damage in the first place.

- Always explore your own "root causes for excavator damage" when you are at fault. While you may be at fault, you may not be "totally" at fault and if the utility shares responsibility that always means a reduction in claim value.

- It is always important for excavators to conduct self-critical analysis of their internal practices that may allow at-fault damages to occur. All excavators whose "intent is to prevent" damage will eliminate both internal and external "excuses" for damage.

7. Best Practices for excavators, especially if you know fiber optic or phone facilities are in the space. It is critical to make the following requests of the utility and their locators and document their answers during an on-site meet:

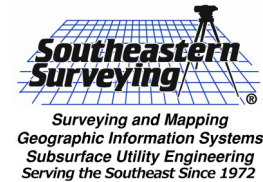
